Gentili Clienti,

vi informiamo che, a seguito di una delibera dell'Autorità di Regolazione dei Trasporti ART 83/2024 che ha prescritto i criteri per l'applicazione da parte di ADR di nuove tariffe sui servizi regolamentati, abbiamo ricevuto un imprevisto e fortissimo aumento dei costi applicati dalla stessa ADR per l'impiego dell'impianto ETV (passaggio direct delivery e/o passaggio/stoccaggio).

Abbiamo avviato dialoghi con ADR sull'argomento, anche insieme alle associazioni di riferimento e agli altri operatori aeroportuali, ma non è stato purtroppo possibile differire o modificare tale fortissimo aumento di costi, a noi applicato già dal 01 dicembre 2024.

Detta misura, a forte impatto sui nostri costi operativi, deve necessariamente trovare un equilibrio tramite un incremento del listino THC che andremo pertanto ad adeguare con effetto dal 01.07.2025 come di seguito riportato. Per maggiore facilità di verifica sono evidenziate in rosso all'interno del nuovo listino le voci soggette a revisione.

TO ALL CLIENTS

Dear Customer,

Please be informed that, following a resolution of the Transport Regulatory Authority ART 83/2024 which prescribed criteria for the application by ADR of new tariffs on regulated services, we have received an unexpected and very strong increase in the costs applied by ADR itself for the use of the ETV system (direct delivery and/or passage/storage).

We have started discussions with ADR on the subject, also together with the reference associations and other airport operators. Regrettably it has not been possible to postpone or modify this very strong increase in costs, which is already applied to us since 01.12.2024.

This measure, with a strong impact on our operating costs, must necessarily find a balance through an increase of our THC pricing list which we will therefore adjust with effect from 01.07.2025 as reported below. For sake of clarity and quick reference, the items subject to revision are highlighted in red.
